### **Candidate Statement**

I am honored to be considered as a candidate for President Elect of the Academic Senate. Although members of the university's community have a broad range of interests and experiences, we share a commitment to discovery. I am fortunate to be part of the MUSE program, which brings together highly engaged undergraduates and faculty from across campus. In March, MUSE sponsored a series of events for students and faculty featuring Margot Lee Shetterly, the author of *Hidden Figures*, Dr. Ellen Stofan, former NASA Chief Scientist, and Ekbe Udoh, an NBA player and committed reader. All three of our guests urged the participants to embrace a wide range of fields; we can love literature and science or history and athletics. I believe it is critical for the university to find ways to communicate our value to the broader community in the current climate of increased public skepticism toward higher education.

I invested years in developing a comprehensive parental leave policy for tenure-track faculty, chaired the Presidential Commission on the Status of Women and the university Diversity Committee, and I help run on an annual lecture and symposium on a topic of interest to women.

I have served on and chaired a number of hearing committees that have considered issues ranging from complaints about hostile work environments to violations of faculty academic integrity to questions of academic freedom. My work on these committees has convinced me of the importance of clear, carefully articulated policies and of the vital importance of clear, balanced, and transparent communication between all sides in difficult situations.

I hope to bring my commitment to the university and my experience in a wide range of roles on campus to the Academic Senate leadership.
