This is an approval request for the development of a Graduate Certificate in Public Policy to be offered through the College of Social and Behavioral Science and administered by the Director of Public Affairs program and the staff of the Master of Public Policy program.

The Master of Public Policy (MPP) program trains in-demand analysts, data managers and policy advocates. The program's interdisciplinary core steeps students in economics, law, research methods, policy analysis, evaluation, and communication skills. The MPP program is one of the few MPP programs west of the Mississippi. Due to the rarity in policy programs, the MPP is a member of the Western Interstate Commission for Higher Educations, allowing students from fifteen other states to attend the program with instate tuition. Despite this huge advantage, the program has not offered any degrees or certificates through distance learning, thus requiring potential students to move to Utah in order to attend, which is often an insurmountable obstacle for working professionals. All courses required by the Graduate Certificate in Public Policy will be available in an online format. The goal in offering a Graduate Certificate in Public Policy is to allow a greater number of people to receive training in the field.

The Graduate Certificate in Public Policy will provide a standalone professional credential for career development as well as an area specialty competence and profile building tool for current graduate students. The target audience consists of graduate students pursuing degrees in fields related to government management (Master of Public Administration, Master in City & Metropolitan Planning) and students interested in advocacy work (Master of Social Work, Master of Public Health, Juris Doctorate, Masters in Education). The non-matriculated target audience is working professionals with policy interests and public or nonprofit sector experience (government employees, nonprofit advocates).

MPP Faculty Consultation

The Master of Public Policy teaching faculty were initially consulted regarding the development of this graduate certificate and voted unanimously in support of this proposal in a faculty governance meeting on February 2, 2016 and approved of the final product October 18, 2018.

The Director of Public Affairs Programs has also reached out to the Chair of the Economics Department and gained approval that this department, which has received development support to convert its courses to fully online versions, is supportive of an online Graduate Certificate in Public Policy that would include ECON courses as certificate electives. Additionally, the MPP program and Economics Department collaborated financially in the development of a certificate elective, ECON 6190: Health

Economics

University Support

The development of the Certificate Program has been encouraged by the Dean of the College of Social and Behavioral Science. The Dean's office is providing financial support to develop online courses.

The development of the Graduate Certificate in Public Policy was encouraged by then SVP Ruth Watkins during the MPP program's seven year graduate council review and allocated TLT and CTLE development resources for 2018/2019. President Watkins is encouraging Graduate Certificate in Public Policy online course development as a part of the University's overall plan for developing online education. *(See Appendix for letters of support)*

Nathanel Martin, Market Analyst for Continuing Educational and UOnline, conducted market research (see Appendix). Each year 787 students complete some training in public policy (61% at the master's level, 5% at the graduate certificate level). The majority of these degrees (over 50% are awarded in California). There are 11,200 unique job postings in the western US over the last year. There were 1,600 regional jobs posted. Based on market demand and competition, the recommendation is to initially develop a graduate certificate in public policy (and as soon as is feasible, an online graduate certificate) to serve as a pipeline to the program for Utah-based working professionals and as a standalone professional credential for career development/add-on for current graduate students.

This interdisciplinary Graduate Certificate in Public Policy offered by the College of Social and Behavioral Science will help fulfill the University of Utah's commitment to the Legislature to prepare our students to meet the demands of a continually changing job market. By providing professional training in the field of policy, this will help meet the Governor's call that 66% of Utahns will have a post-secondary degree by 2020.

The Graduate Certificate in Public Policy does not replicate any efforts at other state institutions. The Master of Public Policy is the only of its kind in the state.

Finances

The Graduate Certificate in Public Policy online course development is being funding through 50% MPP savings and 50% CSBS Dean's Office support. Additional resources are being provided by CTLE and TLT by way of support from President Watkins. Because we expect a small number of students per year to pursue the Certificate, we anticipate minimal impact on administrative tasks related to admissions,

tracking and student counseling. If the number of students increases beyond the number anticipated, then differential tuition revenue from the students should offset any costs related to faculty or other personnel effort.
