I am delighted to add my support for the proposed joint Master of Public Administration and City and Metropolitan Planning degree program. As is outlined in the attached proposal, the joint degree will serve students at the interface of these two programs. The interdisciplinary synergies that this joint program allows is fully consistent with the mission of the College of Social and Behavioral Science.

The Public Affairs Programs have longstanding ties to and collaboration with the College of Architecture + Planning here at the University of Utah. In line with the University's larger emphasis on flexibility in degree seeking and educating an interdisciplinary workforce, the Master of Public Administration program in the College of Social and Behavioral Science is seeking to expand its educational offering to a dual degree program together with the Master of City and Metropolitan Planning. Re: proposed dual degrees

Dear Dean Kieda,

It is my pleasure to write in support of the two dual master's degree programs being proposed by the College of Architecture + Planning and the College of Social and Behavioral Science: a Master of City & Metropolitan Planning (MCMP)—Master of Public Policy (MPP) and a Master of City & Metropolitan Planning—Master of Public Administration (MPA). Our two colleges have been working for several years to bring forth these two proposed dual degrees and I am pleased that we have now completed our preparatory work and can present them to you.

As outlined in the proposal, the MCMP-MPP dual degree takes advantage of a number of natural synergies between the two degree programs. The MPP strives to prepare students "for public service careers in government, nonprofit, and private sectors," including positions that focus on policy, planning, and research. The MCMP trains students as professional planners who similarly work in government, nonprofit, and private sector positions to "assist in creating opportunities to preserve and enhance community life, protect the environment, promote equity, and manage urban growth and change." The natural connections between these distinct yet harmoniously attuned programs is demonstrated by the number of our current PhD students who hold MPP degrees and by the number of our MCMP students who regularly take MPP courses for some of their elective credits.

In a similar fashion, the proposed MCMP-MPA dual degree seeks to take advantage of points of consonance between the disciplines. For years, MCMP students seeking careers in mid- to upper-level local government management have taken advantage of MPA courses to broaden their expertise, while MPA students have sought to use MCMP courses for some of their elective credits. The degree of these "bi-partisan" connections is illustrated by this semester's class in CMP 6620: Negotiation and Dispute Resolution, over 50% of which is comprised of MPA students.

Given the degree of collaborative education already occurring between our two colleges, I am excited to see us take the next step by offering these two dual degree programs for those students who wish to finish complete degrees in each field.

Both of the proposed programs have been vetted by our faculty and approved by departmental and college curriculum committees and by our college council. Thank you for your consideration of these proposals.
