The Department of Anthropology is requesting that the title of our current emphasis in Human Ecology be changed to an emphasis in Evolutionary Anthropology. This change in title was first requested by the biological anthropologists within the Dept. of Anthropology in October of 2019 as they undertook a streamlining of the Departments class catalog and major structure to more accurately reflect current USHE standards relative to class difficulty and catalog number. The new title, "Evolutionary Anthropology", still encompasses "human ecology", but also includes closely-related classes and subjects that are more relevant to current faculty expertise. We expect that this title change, if approved, would benefit both current students as well as the College and USHE as the title is a more accurate reflection of the subject matter now included within this particular emphasis.

Because the proposed emphasis simply organizes existing coursework, the proposed change will not alter instructional programs in the department or college. These changes will not place any additional burden on faculty or staff. No new facilities will be required.

This Departmental request for a title change from "Human Ecology" to "Evolutionary Anthropology" will not alter the basic fact that this particular emphasis within the Department of Anthropology has been designed explicitly to fulfill the mission of and meet the goals of the University of Utah as a research university. The classes within the emphasis allows students to "discover, create, and transmit knowledge" through the academic program. The emphasis includes multiple potential lab-based classes for hands-on learning, as well as integrating several potential field school opportunities. Students are also given the opportunity to work alongside faculty members on their research grants and projects, in addition to creating their own research projects. At the completion of their coursework/research projects, students are encouraged to participate in both the University of Utah Undergraduate Research conference as well as the College of Social and Behavioral Sciences Research event. This participation not only provides them with valuable feedback and experience they'll need in their post-graduation career plans, but these research events also ensure that new data/knowledge is being disseminated in the most efficient manner possible.

Learning Outcomes Assessment

Immediate Implementation: The Department of Anthropology will begin to assess research posters submitted by Anthropology majors for the annual CSBS research symposium each spring semester, beginning in spring 2020.

Posters will be evaluated relative to the relevant learning outcomes above by anthropology faculty as determined by the Department Chair (Prof Jack Broughton) The Department will work with undergraduate studies to ensure

that the pertinent data is being collected from the presentations, and it is expected that the wide range of subjects represented by these posters will provide robust data on all five current learning outcomes.

Immediate Implementation: The Department of Anthropology will work with undergraduate studies to pull pertinent data from certain CANVAS-based Anthropology courses which use one or more of the rubrics noted above.

Beginning with the fall 2019 semester, data-mining will begin with Anthropology 4255 (Race and Culture). If the methodology to integrate CANVAS-based courses and learning outcome assessment is successful for the fall 2019 semester, then the methodology will be used to extract data from past versions of the class, where and if possible. The Department may also consider extending said data-collection to additional online classes pending the outcome of this noted trial.

Future Implementation: All undergraduate students seeking an Anthropology (B.A. or B.S.) degree will have an opportunity to enroll in a capstone course. The capstone course will be organized by an advanced graduate student in the department who will facilitate lectures and discussions. Each student will be required to participate in biweekly lectures and engage in alternating biweekly discussions. Speakers will include faculty within the program and experts from outside the University. Topics will cover the breadth of Anthropology structured around the above learning outcomes.

Assignments: All students will be required to a) complete a final paper and b) give a final presentation. Students will be encouraged to continue refining projects initiated in previous Anthropology courses, or to work with faculty and/or outside speakers to develop a new project. Project topics are flexible based on the students proposed career.

Evaluation: Using a rubric designed to assess the learning outcomes, select faculty from the Department will evaluate students based on a final paper and a final presentation.

The Department of Anthropology is requesting that the title of our current undergraduate emphasis in Human Ecology be changed to Evolutionary Anthropology. The proposed change resulted from a broader reorganization of the Department's class catalog and major structure and will benefit current students, the University, and USHE as the new title better reflects current faculty expertise and the subject matter now included within the emphasis.
