Program/Unit Description

The Department of Art and Art History is sufficiently poised to introduce an emphasis in Illustration to its offerings. The new Illustration emphasis will serve to connect the existing two-dimensional emphasis areas (Graphic Design, Printmaking, and Painting & Drawing), creating new possibilities for studio art majors. Four new Illustration courses have been created to support the program. Existing classrooms within the art building will be used, in particular those on the third floor, which have space to schedule the four new Illustration courses, and are already equipped with easels and specially designed drawing desks, as well as the Department's new Mac lab (room 365). Existing faculty, in the areas of Painting and Drawing, Graphic Design, Printmaking and Art History, and those teaching the Department's Foundations sequence, will serve the Illustration emphasis along with our recent (July 2019) tenure line hire in Illustration.

The Department of Art & Art history currently offers seven BFA in Art emphases, and the proposed Illustration emphasis follows a similar structure to the existing emphases. The proposed emphasis includes four new courses; core courses in the areas of drawing, painting, printmaking, and art history; and a range of art electives that allow students to choose courses that fit their schedules, interests, and strengths. The focus in crafting the Illustration four-year plan, was to ensure that students could realistically complete the emphasis and graduate on schedule.

The Illustration Emphasis within the Department of Art & Art History will provide students the opportunity to study a broad range of approaches found within the field of Illustration. In the arts field, Illustration incorporates both contemporary and traditional practices. The field of Illustration has undergone many changes and advances over the past few decades, as both tools and publication platforms have expanded exponentially. As a result of its adaptability to digital and web-based platforms, Illustration is garnering an increased interest as a relevant and valuable art form amongst studio art practitioners.

The presence of Illustration in both the digital and analog formats is widespread. While illustrators continue an ongoing practice in analog platforms such as printed books, posters and zines, the field has integrated an array of new technologies. Digital platforms have increased the possibilities for the publication of illustrations, as evidenced by the presence of illustration on websites, blogs, advertisements, print on demand, instructional materials, and digital books. The market for illustration professionals has shifted and expanded due to a growth in small businesses looking for unique identities; the over-saturation of photography from camera phones has generated even further market demand for more stylized imagery.

Developments in digital tools, such as Wacom tablets and digital styluses, are providing illustrators many more options with which to develop imagery. Touchscreen technological development and an increasing number of new products are now widely available and affordable, resulting in the re-defining of illustration practice, and a digital sophistication in the finished aesthetic. This factor, along with the continuous development of software programs (such as the Adobe Suite), has contributed to the re-shaping of contemporary illustration practice.

The Department of Art and Art History is in the process of preparing an application for NASAD (National Association of Schools of Art and Design) accreditation, and this proposed Illustration emphasis is in line with the NASAD requirements. The Department of Art and Art History full roster of full-time faculty reviewed the proposed Illustration emphasis and unanimously approved it, including the four new proposed courses, 8/28/19.

We see the possibilities for increased enrollment in the Department of Art and Art History, as students are currently opting to attend other four-year institutions in the State, such as BYU and UVU, in order to major in Illustration. In order to stay current with national and international trends in the education and professional field, there is an urgent need to develop Illustration as an emphasis.

While there continues to be a high demand for well-crafted analog illustration work in the form of printed materials, the internet has created a significant demand for illustrators that utilize digital platforms. This explosion of labor market demand allows for illustrators to work for a wide range of international clients without having to leave their homes. The demand for illustrators is high and will only continue to increase with the exponential growth of online platforms.

Nationally, the US Bureau of Labor Statistics predicts a 4% growth in creative industries with higher demand in technology based creative outlets, which would include Illustration (https://www.bls.gov/ooh/arts-and-design/home.htm). In 2018, the Salt Lake Tribune published an article titled 'Salt Lake City is named the No.1 Place for Creative People' (https://www.sltrib.com/news/business/2018/05/18/salt-lake-city-is-called-the-no-1-place-for-

creative-people-insert-haiku-here/). This article highlights the many advantages of affordable housing and studio/work spaces that Salt Lake City has to offer creatives. Many American metropolitan cities have become unaffordable for those in the creative industry, thus Salt Lake City is in a strategically prime position to absorb this group. In addition, large employers such as Adobe, Backcountry, Overstock, and Marriot are driving a continual demand for employees with creative skills such as illustrators.

The Illustration emphasis will serve the University of Utah's Mission in the following ways:

Strategic Goal 1. Develop and Transfer New Knowledge.

Students will gain new knowledge developing the skills needed for success in the field of illustration. They will have the opportunity to develop their own unique voice through media exploration and a diverse approach to what comprises illustration. The presence of the Illustration emphasis within the BFA in Art, alongside the additional newly hired tenure-line faculty member in Illustration, will enhance both the undergraduate and graduate programs within the Department of Art and Art History. This addition to the department and college creates more options for students and increases the potential for recruiting students nationally.

Strategic Goal 2. Promote Student Success to Transform Lives.

The development of new courses in illustration expands possibilities for online course offerings within the Department of Art and Art History, which will aid students in the ability to complete degrees in a timely fashion. The Illustration emphasis provides students with the opportunity for more in depth study in the area, encouraging students to develop their own unique individual voices and aesthetic language. This experience will expand prospects for student as they move into professional careers. Current career paths for those will illustration skills are varied, including web-based professions, educational industries, illustration for business, illustration for the publication field, character design, packaging and identity, sequential art, and children's book publishing. Additionally, the work created by students during their studies will inform and impact the department and campus community in a variety of ways.

Impact on Other USHE Institutions

We anticipate the Illustration emphasis will increase enrollment in the Department of Art and Art History. Currently, without offering an illustration emphasis area, prospective students who in fact want to attend the University of Utah chose to go elsewhere. Many of these prospective students are going out of state in pursuit of an education in Illustration, therefore we see this as an opportunity to increase enrollment through offering a highly sought-after course of study here at the University of Utah.

Other four-year institutions in the state offer illustration, yet we are not looking to replicate these offerings. Rather, we aim to develop our own unique program that focuses heavily on craft and excellence.

Finances

Faculty/Curriculum

Following approval from the College of Fine Arts to hire an Assistant Professor of Illustration, the position was successfully filled and Michael Hirshon who began his faculty position in Fall 2019. As the new Assistant Professor of Illustration, Professor Hirshon will teach all four of the new Illustration courses as part of his teaching load and, if needed, could teach other existing courses. Should student demand dictate the need to offer more than one section of any of these courses, we have capable existing adjunct instructors. The Illustration curriculum requires a number of existing courses in Painting, Drawing, Printmaking, Graphic Design and Art History for which faculty and facilities are already in place. Students in the Illustration emphasis will take classes with other department majors and minors using existing classrooms in the Art and Art History Building. Should the Illustration emphasis grow, the need may arise for an additional faculty member.

Facilities

Existing facilities housed in the Department of Art and Art History will suffice. Painting and Drawing classrooms are equipped with the requisite specialized drawing desks and easels. Recent upgrades to the Department's Mac lab have resulted in an up to date digital classroom where Illustration courses may be taught. A recent teaching grant enabled the department to purchase professional Wacom tablets, which are available for students to use in the Department Mac lab.

Administration

Tenured faculty Alison Denyer (Painting and Drawing) and Dan Evans (Graphic Design) will oversee the Illustration emphasis alongside an advisory team of departmental faculty members. This group will work closely with our newly hired Assistant Professor in Illustration, Michael Hirshon, for the purpose of mentoring and assisting with necessary departmental processes. Michael Hirshon will ultimately serve as the Area Head for the Illustration emphasis. The Department of Art and Art History Chair will oversee the Illustration emphasis along the same lines as the department's other emphases.

Student Services/Advising

The College of Fine Arts uses a team advising system in which four professional advisors are cross-trained in all of the degrees and emphases offered by the college's five academic units. Thus, each advisor is already prepared to advise students in any of the emphases available to students across the CFA, and they assure us that they will be able to add one additional emphasis to this advising structure. In addition, because of the team approach, enough advising appointments are available for each CFA student to meet with an advisor at least once a semester, a ratio that is high in comparison to other departments and colleges across campus and the nation.

Library and Information Resources

The Marriott Library currently serves the needs of our faculty and students across all the areas of the Department of Art and Art History extremely well. In addition, there is a small fine arts library collection housed in the department with materials available for students.

The proposed program is an important expansion to our offerings and is intended to offer a career path to professional illustration. The program proposal was originated by a group of faculty members from Graphic Design and Illustration areas in the department, then it went to the full faculty for discussion and approval. The Department of Art and Art History has hired a tenure-line faculty member, Michael Hirshon, to support the emphasis. Illustration is offered in many other local universities and has put the University of Utah at a disadvantage in recruiting talented students, approval of the Illustration Emphasis will rectify this recruitment problem.

I offer my support to establish an Illustration BFA emphasis in the Department of Art & Art History.
